The Department of Population Medicine and Diagnostic Sciences, Section of Clinical Pathology at Cornell University in upstate New York is seeking a clinical track faculty member to join our dynamic, vibrant and motivated team of residents and 3 board-certified clinical pathologists. A DVM (or equivalent degree) and board certification or eligibility in clinical pathology is required for this position. The initial three year appointment is renewable with potential for reappointment and/or promotion under established College of Veterinary Medicine guidelines. The position will be filled at either the Assistant or Associate Clinical Professor level, depending on the qualifications of the candidate.

Our mission is to provide diagnostic service of exceptional quality, teach our clinical discipline to veterinary students and veterinarians, and advance our discipline through resident training, critical thinking, and research. We are seeking an enthusiastic colleague who desires a career that will promote the advancement of veterinary clinical pathology through the aforementioned instructional and novel investigative efforts that are core to our mission as a section. This colleague will join an encouraging, supportive, interactive, collegial and innovative group of clinical pathologists, trainees and laboratory technologists. The Clinical Pathology Laboratory is a high volume laboratory providing diagnostic service to the Cornell University Hospital for Animals and the Animal Health Diagnostic Center, which receives samples from international and national sources. We see a wealth of classic and challenging cases in various species and also provide research support to a number of investigators both on and off campus. Flow cytometry and other specialized tests are used routinely.

The individual in this position will devote a majority of effort to the diagnostic and teaching missions of the section. This will primarily include examination and interpretation of cytologic, hematologic, electrophoretic, flow cytometric and urinalysis samples, as well as teaching clinical pathology to veterinary students, residents, and interns. Additional efforts will include providing continuing education to practicing veterinarians, validation of new diagnostic tests, and creation of new or modification of existing clinical pathology web-based teaching resources (<http://eClinPath.com>; Certificates in Veterinary Clinical Pathology). Some effort will be allocated for scholarly activities, including primary and/or collaborative clinical and applied research, and publication of case series or case reports and book chapters, as well as service to the College of Veterinary Medicine, Cornell University and the American Society of Veterinary Clinical Pathology. The candidate should have strong interpersonal skills and the ability to work cooperatively with all faculty and staff in the College, Hospital, and the Animal Health Diagnostic Center. Time and substantial resources will be provided to study for the board examination, if required.
